



The purpose of this mailer is to help you make a comparison between Orange County Power Authority (OCPA) and Southern California Edison (SCE) rates and see the renewable energy mix of each to decide which service and rate works for you. The chart below illustrates the estimated electricity costs for a typical business customer with an average monthly energy usage of 961 kilowatt hours (kWh). This comparison is based on OCPA rates approved by its Board of Directors and effective as of April 1, 2022. SCE rate options are based on rates effective April 15, 2022. Both OCPA and SCE's rates are subject to change.

*As of June 2, 2022, SCE's Green Rates for 50% and 100% of energy delivery are closed to all new customers due to full subscription to approved Green Energy resources. SCE is expected to launch a solicitation later this year for additional contracts to support the Green Rate programs.

All of OCPA's rate products are open to all customers. Generation Rate reflects the cost of producing or purchasing electricity to power your business. This rate will vary depending on your service provider and rate plan. SCE Delivery Rate is a charge assessed by SCE to deliver electricity to your business. This rate depends on usage. Surcharges represent the Cost Responsibility Surcharge (CRS) and Franchise Fee (FF) that are applicable to Community Choice Aggregation (CCA) customers and SCE customers that select a Green Rate.

Unspecified power is electricity that has been purchased through open market transactions and is not traceable to a specific generation source. Unspecified sources of power are typically a mix of all resource types, and may include renewables.

The CRS is a surcharge to recover costs associated with power purchases made on behalf of customers, prior to a customer's switch to a CCA or SCE Green Rate. The FF recovers taxes owed to a city in exchange for allowing SCE to utilize electrical distribution lines throughout the property of the city. SCE acts as the collection agency for the FF surcharge which is levied by cities and counties for all customers.
